



MARKET DAY STALLHOLDER APPLICATION

IMPORTANT INFORMATION

- The Markets on the Green are predominantly a makers market and only the goods described and approved on the registration form may be sold from the stall. Goods sold within the market must be principally made, manufactured or produced by the stallholder
- Exceptions to this rule may be approved by the Market Manager on the grounds of the stallholder's demonstrable and significant involvement in the manufacturing of the product and the product contributes to customer appeal and uniqueness.
- By completing this Site Application you undertake to comply with the Concord Markets rules. Please read them carefully as they will determine your continuing tenure as a stallholder at the Concord Markets.
- The Market Manager will consider all applications under the criteria laid down under section 6 of the rules. All Decisions on Site Applications are final and no correspondence will be entered into.
- Unsuccessful applications cannot be resubmitted, however if an applicant wishes to reapply they can do so by submitting a new application which better addresses the criteria for the Market Manager to consider.
- Successful applicants will be allocated a casual site or placed on a waiting list to receive a casual site allocation. A successful application does not in any way guarantee a site, or site holder status. Such applications remain current for one calendar year from the date of approval.
- All successful applicants are required to ensure their business practices, goods and services to comply with all relevant product, safety, business and trade legislation. Necessary Registration and License Certificates are to be displayed as required. All electrical equipment must have valid tag and testing certification. All Food / Health statutory requirements are to be adhered to. Proof of compliance is mandatory.
- Public and Product Liability insurance to the value of \$10,000,000 is required and is to be kept current at all times. Copies of your "Certificate of Currency" are to be provided to the Market Manager with your application.
