Participant/Attendee Terms and Conditions

I (Participant/Attendee) agree by registering and/or attending the Surgical Robotics + Innovation Summit (**Event**) hosted by Sydney Local Health District (**SLHD**) on Friday 14 and Saturday 15 June 2024 at the Sydney Masonic Centre, Sydney (**Venue**) to abide by the following Terms and Conditions (**Terms**):

1. I understand that all information provided at the Event is for educational purposes only.
2. Unauthorised filming or transmitting of any live or video surgery that may be presented during the Event is strictly prohibited and I understand Term 6 applies if I am found to be filming in these circumstances. In addition, I will be required to delete any unauthorised footage filmed.
3. Unless otherwise instructed by SLHD, the use of photographs is permitted on the provision that any visual material that involves a patient contains no identifiable personal information about the patient, including but not limited name and date of birth is disclosed.
4. I acknowledge that I may be filmed, sound recorded and/or photographed by SLHD at the Event and consent to the release, publication, exhibition or reproduction of all recorded media and photographs of my appearance, voice, and name by SLHD or a third party approved by SLHD, for any purpose whatsoever in perpetuity including but not limited to use on websites, in social media, reports and advertising. SLHD is not obliged to provide me with any such recording or photographs.
5. I agree to comply with all reasonable directions issued by SLHD or the Venue operators at the Event.
6. SLHD reserves the right, without any liability, to refuse admission to, or to remove a Participant/Attendee from the Event, in its absolute discretion, including (without limitation), for failure to comply with these Terms or if in the opinion of SLHD the Participant/Attendee represents a security risk, nuisance or disturbance to the running of the Event, or behaves in a threatening or offensive manner.

7. Cancellation of Event Registration

7.1 All requests for cancellation of Event registration by Participants/Attendees must be notified in writing via email to slhd-rpaias@health.nsw.gov.au and include name of registrant.

(a) For valid requests received prior to 27 April 2024 a refund of the total ticket price will be given.

(b) For valid requests received between 28 April - 25 May 2024 a partial refund minus 50% of the total ticket price for administration costs will be given.

(c) For any requests received from 26 May 2024 onwards, there will be no refunds.

7.2 All refunds will be processed within two weeks of being approved by SLHD.

8. Modification/ Postponement/ Cancellation of the Event or any part of the Event

8.1 SLHD reserves the right at any time to:

(a) change the format, program, speaker, content, location and timing or any other aspect of the Event, including during the Event;

(b) pull any live transmission from being broadcast. In the event this occurs, every effort will be made to provide a program of equivalent standard.

(c) postpone the Event or any part of the Event; or

(d) cancel the Event or any part of the Event,

and will not be liable for any damages, costs, losses or expenses of any kind that I may incur or suffer as a result of or in relation to SLHD modifying, postponing or cancelling the Event or any part of the Event.

9. Limitations of Liability and Indemnity

9.1 To the maximum extent permitted by applicable law, SLHD, its employees and agents will not be liable for personal injury or death, property damage, or any other loss (including without limitation, liability for negligence, breach of these Terms or any other agreement), damage, cost or expense (including, without limitation, loss of profits, business interruption, direct, indirect, special, punitive or consequential loss or other damages) that I may incur or suffer arising out of or in connection with the Event.

9.2 I acknowledge and agree that I am at all times responsible for my personal possessions such as bags, mobile phones and other items I bring to the Event and must not leave any of my possessions unattended at any time.

9.2. I agree to fully indemnify and hold SLHD, its employees and agents harmless from any claim, cost, demand, liability or damage (including legal costs, professional costs and other expenses on a full indemnity basis) incurred by SLHD arising out of or in connection with Participant/Attendee's attendance at the Event, including but not limited to the Participant/Attendee's

(a) breach of these Terms;

(b) use of the Venue;

(c) damage to the Venue or any goods located at the Venue;

(d) or the infringement of any intellectual property or other right of any third party.

10. General

10.1. SLHD reserves the right to amend these Terms from time to time as updated on the Event's website <https://sydneyroboticssummit.com/>. It is my responsibility to review the Terms prior to attending the Event.

10.2. The failure or delay on the part of a party in exercising, in part or whole, any power, right or remedy conferred upon that party by these Terms shall not operate as a waiver of that power, right or remedy.

10.3. If any provision of these Terms is found by any court, tribunal, administrative body or authority of competent jurisdiction to be illegal, invalid or unenforceable then that provision shall, to the extent required, be severed from these Terms without affecting any other provisions of these Terms which shall remain in full force and effect.

10.4. The interpretation and construction of these Terms shall be governed and determined in accordance with the laws of New South Wales and each party submits to the jurisdiction of the courts of New South Wales.
